



## PROMOTION RULES

### *Grande Vie Promotion*

---

#### 1. DEFINITIONS

**1.1. *Grande Vie Promotion*** (hereinafter the “**Promotion**”):

Promotion held pursuant to the *Sales promotion games By-law* (CQLR, c S-13.1, r. 4).

**1.2. Loto-Québec:**

The Société des loteries du Québec, the party responsible for organizing the Promotion.

#### 2. ELIGIBILITY

Only individuals who are eighteen (18) years of age or older can enter the Promotion, provided that they have an Espacejeux account on lotoquebec.com, that their identity has been confirmed according to the applicable terms and conditions, that they are residents of Québec, and that they are not enrolled in a self-exclusion program that bars them from Loto-Québec's gaming website and/or Québec casinos and gaming halls.

#### 3. DURATION OF THE PROMOTION

The Promotion will run from April 5, 2021, at 5 a.m., until April 25, 2021, at 11:59:59 p.m.

#### 4. HOW TO ENTER

**4.1.** To enter the Promotion, eligible individuals must first enter promo code<sup>1</sup> GRANDEVIE5273 in their Espacejeux account during the Promotion period. Only one (1) entry is permitted per eligible individual for the duration of the Promotion.

**4.2.** Once eligible individuals have entered the Promotion, in accordance with Section 4.1, they will automatically receive one (1) entry for the draw, as described in Section 5 of the rules herein, for every Grande Vie play they buy with real money at lotoquebec.com during the Promotion period. The cost of one play is three dollars (\$3).

**4.3.** There is no limit to the number of entries each eligible entrant can earn during the Promotion period.

#### 5. DRAW AND PRIZE DESCRIPTION

<sup>1</sup>To enter the promo code, eligible individuals must click on My Espacejeux in the upper right-hand corner of the screen, then click on My Promotions in the right-hand menu.

**5.1.** The Promotion draw will take place on April 27, 2021, in the form of an electronic draw, from all the entries duly received, and conducted using Loto-Québec's computer system, at Loto-Québec's head office in Montréal, in order to select one (1) winner.

**5.2.** The draw will be conducted and supervised by authorized Loto-Québec representatives.

**IN THE EVENT THAT THE SELECTED ENTRY IS VALID AND COMPLIES WITH THESE RULES:**

**5.3.** In the event that the selected entry is valid and complies with the rules herein, the winner will receive a prize of seven thousand dollars (\$7,000), which will be deposited in their Espacejeux account<sup>2</sup>.

**IN THE EVENT THAT THE SELECTED ENTRY IS NOT VALID OR DOES NOT COMPLY WITH THESE RULES:**

**5.4.** In the event that the selected entry is not valid or does not comply with the rules herein, or that a person whose entry was selected does not comply with the terms and conditions of the rules herein, a new entry will be drawn at random until a valid entry that complies with the rules herein is drawn, in which case the aforementioned terms and conditions in **Section 5.3 IN THE EVENT THAT THE SELECTED ENTRY IS VALID AND COMPLIES WITH THESE RULES** will apply.

**6. PRIZE REMITTANCE**

The winner, designated in accordance with Section 5 of the rules herein, will be contacted by email or phone by a member of Loto-Québec's staff, who will then confirm their win and inform them of the claim details and conditions. The winner will have forty-eight (48) hours to confirm that they accept the prize awarded to them. If they fail to confirm that they accept the prize by the deadline, they will not be entitled to the prize or any compensation of any kind.

Before awarding them their prize, Loto-Québec may require the winner to show a valid government-issued photo ID document. Once the winner's identity has been checked and confirmed, and their compliance with the rules herein has been attested, they will receive their prize, as described in Section 5 of the rules herein and in accordance with the terms and conditions set by Loto-Québec.

**7. NAME, ADDRESS AND PHOTOGRAPH**

The winner's name, address, photograph or video, as well as any other information voluntarily provided by them, may be used not only for the purposes of the draws described in the rules herein, but also for advertising purposes by Loto-Québec and its subsidiaries, particularly on the Internet (including on social media). No broadcasting, printing or advertising rights may be claimed by the winner in this regard.

**8. OTHER RESTRICTIONS**

**8.1.** Loto-Québec reserves the right to substitute a prize with another one of equal value.

<sup>2</sup>The cash prize will automatically be deposited in the winner's Espacejeux account approximately seventy-two (72) hours after the draw. The betting money can be used to play any game on lotoquebec.com, and cannot be redeemed for cash or refunded.

- 8.2.** Loto-Québec reserves the right to cancel the Promotion, in whole or in part, or postpone it for any reason whatsoever, or in cases of fortuitous events or force majeure. Loto-Québec can also amend these rules at any time, in which case the amended rules will be made available to the public.
- 8.3.** Loto-Québec declines all liability towards anyone should the Promotion be cancelled, postponed or amended, or in the event of a computer system failure or malfunction.
- 8.4.** Loto-Québec declines all liability towards anyone who may not have received their electronic entry (or entries) or earned the right to enter the Promotion.
- 8.5.** Loto-Québec declines all liability in the event of any situation, incident or other occurrence that prevents anyone from meeting entry deadlines or claiming their prize.
- 8.6.** Any winner who is enrolled in a self-exclusion program that bars them from Loto-Québec's online gaming website and/or Québec casinos and gaming halls at the time of the draw will not be entitled to the prize they won.
- 8.7.** If an entrant violates the rules herein, makes a false statement, attempts to cheat, commits fraud, acts in collusion or conspires with a third party, their entry will automatically be void and they will be disqualified from further participation in any event related to the Promotion.
