



PROMOTION RULES

THE 4-PAYDAY WEEK

1. DEFINITIONS

1.1 *The 4 Payday Week* (hereafter referred to as the “**Promotion**”):

Promotion held per the Sales promotion games By-law (CQLR, c. S – 13.1, r. 4).

1.2 **Loto-Québec:**

The Société des loteries du Québec, responsible for organizing the Promotion.

2. ELIGIBILITY

Only persons who are eighteen (18) years of age or older may participate in the Promotion, provided they have an Espacejeux account on lotoquebec.com and validated their identity according to applicable terms, are residents of Québec and not registered in a Loto-Québec online gaming site, gaming hall or casino self-exclusion program.

3. DURATION OF THE PROMOTION

The Promotion will be held from 9:00:00 a.m. on April 2, 2018, to 11:59:59 p.m. on April 22, 2018.

4. HOW TO PARTICIPATE

4.1 To participate in the Promotion, eligible persons must first register by entering promo code¹ JEUDI3049 where indicated in their Espacejeux account during the Promotion period. Each eligible person will be allowed to register only once (1) during the entire Promotion period.

4.2 Once duly registered in accordance with Section 4.1, persons eligible for the Promotion will automatically receive **one (1) entry** for the draw described in Section 5 of the rules herein for each Lotto 6/49 play purchased online using real money during the Promotion period. The cost of one play is three dollars (\$3).

4.3 Eligible persons may receive an unlimited number of entries during the Promotion period.

5. DRAW AND PRIZE DESCRIPTION

- 5.1** The Promotion's random electronic draw will be conducted on April 24, 2018, at Loto-Québec's head office in Montréal using its computer system in order to determine one (1) Promotion winner.
- 5.2** The draw among all entries duly registered in accordance with the rules herein will be conducted and supervised by authorized Loto-Québec representatives.

IN THE EVENT THAT THE ENTRY DRAWN IS DEEMED VALID AND COMPLIANT WITH THE RULES HEREIN:

- 5.3** In the event that the entry drawn is valid and compliant with the rules herein, the winner will receive a prize worth eight thousand dollars (\$8,000), which will be paid by four (4) cheques of two thousand dollars (\$2,000).

IN THE EVENT THAT THE ENTRY DRAWN IS DEEMED INVALID OR NON-COMPLIANT:

- 5.4** Should the entry drawn be deemed invalid or non-compliant with the rules herein or the person whose entry is drawn does not comply with the terms indicated in the rules herein, another entry will be drawn at random. Such draws will take place until an entry is found to be valid and compliant, in which case the terms described in Section **5.3 IN THE EVENT THAT THE ENTRY DRAWN IS DEEMED VALID AND COMPLIANT** above will apply.

6. PRIZE REMITTANCE

A Loto-Québec staff member will e-mail or phone the winner designated in accordance with Section 5 herein to confirm the win and provide details and terms for claiming the prize. The winner will have forty-eight (48) hours to confirm acceptance of the prize awarded. Should acceptance not be confirmed by the prescribed deadline, the selected person will not be entitled to the prize or any compensation of any kind whatsoever.

Loto-Québec may require the winner to show a valid form of government-issued photo ID before remitting the prize. Once the winner's identity has been checked and confirmed and the person has complied with the rules herein, the prize described in Section 5 of the rules herein will be awarded according to the terms determined by Loto-Québec.

7. NAME, ADDRESS AND PHOTO

The winner's name, address, photograph and video, and any other information voluntarily provided, may be used by Loto-Québec and its subsidiaries not only for the draws described in the rules herein, but also for advertising purposes, particularly on the Internet (including in social media). The winner must waive all rights to compensation related to broadcasting, printed material and advertising.

8. OTHER RESTRICTIONS

- 8.1** Loto-Québec reserves the right to replace a prize, in whole or in part, with another of equal value.
- 8.2** Loto-Québec reserves the right to cancel or delay the Promotion, in whole or in part, for any reason whatsoever or due to an act of God or force majeure. Loto-Québec may also amend these rules at any time, in which case the amended rules will be made available to the public.
- 8.3** Loto-Québec declines all liability towards anyone should the Promotion be cancelled, delayed or modified, or in the event of a computer system failure or malfunction.
- 8.4** Loto-Québec declines all responsibility towards any person who may not have received one or more electronic entries or a chance to participate in the Promotion.
- 8.5** Loto-Québec declines all responsibility in the event of any situation, incident or any other occurrence that may prevent a person from meeting participation deadlines or confirming acceptance of a prize within prescribed deadlines.
- 8.6** A winner who is registered in a Loto-Québec online gaming site, gaming hall or casino self-exclusion program at the time a prize is claimed will not be entitled to receive said prize.
- 8.7** In the event that a participant violates the rules herein, makes a false statement, attempts to cheat, commits fraud, acts in collusion or conspires with a third party, their participation will be automatically cancelled and they will be ineligible for any other event related to the Promotion.

9. DISPUTES

Eligible persons agree to comply with the rules described herein as well as all other applicable rules and conditions indicated on lotoquebec.com. Any dispute relating to this Promotion, whether regarding conduct and/or award of any prizes, will be settled according to the rules herein and the Sales promotion games By-law (CQLR, c. S – 13.1, r. 4).
