

PROMOTION RULES
Célébration 2022 – Extra Entries
November 1, 2021, to January 5, 2022

1. DEFINITIONS

1.1. *Célébration 2022 – Extra Entries Promotion* (hereafter referred to as the “**Promotion**”):

Promotion held per the Sales promotion games By-law (CQLR, c. S – 13.1, r. 4).

1.2. LOTO-QUÉBEC:

Société des loteries du Québec (Loto-Québec), the organization responsible for the Promotion.

2. ELIGIBILITY

Only persons 18 years or older may participate in the Promotion.

To register for the Promotion, eligible persons must hold a legitimate *Célébration 2022*, edition number 20-1002, lottery scratch ticket bearing a valid Internet code (hereafter referred to as the “Ticket”).

Eligible individuals can purchase a Ticket from an authorized Loto-Québec retailer. Promotions offering Ticket prizes can also be held by any participating establishment.

3. DURATION

The Promotion will run from 9 a.m. on November 1, 2021, to 2:30 p.m. on January 5, 2022, and the draw will be conducted as soon as possible after that hour.

4. HOW TO PARTICIPATE

An eligible person can participate for the draw of the 5 Extra Entries by registering online.

➤ **ONLINE REGISTRATION**

4.1. Eligible individuals must go to lotoquebec.com/2chance and log into or create their Espacejeux account in order to enter the Internet code provided on their Ticket into the entry form, OR scan the registration code with their mobile phone using the Lotteries app. They must then fill out all required fields to complete their registration for the Promotion. Once eligible individuals submit the Internet code, a registration confirmation message will be displayed. Eligible individuals must register by 2:30 p.m. on January 5, 2022.

4.2. Entry forms that contain any mistake of any kind whatsoever, or violate any provision of the rules herein will be deemed invalid

- 4.3. Only Québec residents and person physically in Quebec at the time of the registration may register and participate in the Internet draw.
- 4.4. Eligible persons must be able to present their participating Ticket bearing a valid Internet code in order to receive a prize.
- 4.5. The Internet code will be valid for only one entry. Only one person is allowed per registration.

5. DRAW DETAILS AND PRIZE DESCRIPTION

- 5.1. The draw to randomly select five (5) EXTRA ENTRIES FOR THE TV DRAW among the online registration will be conducted in accordance with the rules herein.
- 5.2. The draw will be performed by Loto-Québec's computer system. The random draw to select the winners will be conducted at Loto-Québec's draw room in Montréal on January 5, 2022 as soon as possible after 2:30 p.m.
- 5.3. The draw will be performed by the employee responsible for Loto-Québec's draws, under the supervision of an external auditor.
- 5.4. Person whose participation has been drawn will be contacted by a Customer Services employee by telephone in order to ask for proof of ID.
- 5.5. Selected persons who cannot be contacted within 36 hours of the draw will be entitled to a \$1,000 prize and the minimum \$25,000 prize offered during the draw, provided that they comply with the terms for claiming a prize.
- 5.6. In the event that persons reached by telephone cannot meet the terms for claiming a prize, they will not be entitled to the prize.
- 5.7. In addition to providing proof of ID at the time of prize claim, persons must have in hand the *Extra Entries for the TV Draw* portion of the ticket fill out a prize claim form.
- 5.8. In the event that the person does not have the *Extra Entries for the TV Draw* portion of their Ticket at the time of prize claim, they may still be entitled to a \$1,000 prize and to participate in the Célébration 2022 gala, as appropriate, a total of \$26,000 prize if they make their claim after the deadline, but according to the terms for claiming a prize.

6. PRIZE DESCRIPTION

Each prize consists in an invitation to an event as part of Célébration 2022 activities, during which cash prizes will be drawn among eligible contestants. Event details will be revealed later.

7. HOW TO CLAIM A PRIZE

To be entitled to participate in the draw, persons eligible for the Extra Entries for the TV Draw promotion must comply with the terms indicated in Section 5 of the rules herein. The

following prizes will be awarded during draws: 1 \$1 million prize, 2 \$100,000 prizes, 3 \$75,000 prizes, 6 \$50,000 prizes or a minimum of \$25,000. Prizes will be awarded as a cheque.

8. COLLECTION AND USE OF INFORMATION

By registering for the Promotion, eligible individuals acknowledge that they have read, understood and agree to abide by the terms and conditions of the rules herein as well as Loto-Québec's Privacy Policy. By taking part in the Promotion, they authorize Loto-Québec to gather, analyze, use and retain information regarding Célébration 2022 ticket purchases during the Promotion period. They also authorize Loto-Québec to send them offers according to those purchases if they checked the box to that effect. Any offers will be sent by email. Loto-Québec may use data and information gathered as part of the Promotion at its discretion, provided that none of the information is linked to third parties and that the confidentiality and security of private information is protected.

9. FIRST AND LAST NAME, REGION AND PHOTOGRAPH

The first and last name, region and photograph of each winner, as well as any other information provided, may be used by Loto-Québec and its subsidiaries not only for the draws stipulated in the rules herein, but also for advertising purposes, including on the Internet and social media, and in various magazines distributed to its customers. Winners must waive all rights to broadcasting, printed material and advertising or any compensation of any kind whatsoever related to the draw.

10. OTHER RESTRICTIONS AND CONDITIONS

- 10.1.** Prizes must be accepted "as is" and may not be transferred or exchanged. Loto-Québec reserves the right to replace a prize with another of equal value.
- 10.2.** Loto-Québec reserves the right to appoint a representative to participate in the Celebration 2022 gala, if an eligible person or his representative refuses to comply with the directives and instructions issued by the *Direction générale de la santé publique du Québec* applicable to Loto-Québec.
- 10.3.** Loto-Québec reserves the right to cancel or delay the Promotion, in whole or in part, without notice and for any reason whatsoever or due to an act of God or force majeure. Loto-Québec may also amend the rules herein at any time, in which case revised rules will be made available to the public.
- 10.4.** Loto-Québec declines all responsibility should the Promotion be delayed, cancelled or amended.
- 10.5.** Loto-Québec declines all responsibility in the event of the loss or theft of any Ticket or Coupon, or any other situation, incident or event that may prevent a person from meeting participation deadlines or claiming a prize within prescribed deadlines.
- 10.6.** In the event that a participant violates the rules herein, makes a false statement, attempts to cheat, commits fraud, acts in collusion or conspires with a third party,

their eligibility for the Promotion will be automatically cancelled and they will be inadmissible for any other event related to the Promotion.

11. DISPUTES

Any dispute relating to this Promotion, whether regarding conduct and/or award of any prizes, will be settled according to the rules herein and the Sales promotion games By-law (R.S.Q., c. S – 13.1, r. 4).
