

PROMOTION RULES

THE 4-PAYDAY WEEK

1. DEFINITIONS

1.1 *The 4 Payday Week* hereinafter referred to as the “**Promotion**”):

Promotion held per the Sales promotion games By-law (CQLR, c. S – 13.1, r. 4).

1.2 **Loto-Québec:**

The Société des loteries du Québec, responsible for organizing the Promotion.

2. ELIGIBILITY

Only individuals who are eighteen (18) years of age or older can enter the Promotion, provided they have an Espacejeux account on lotoquebec.com and confirmed their identity according to applicable terms, are residents of Québec and not registered in a self-exclusion program operated by Loto-Québec through its online gaming site, gaming halls or casinos.

3. DURATION OF THE PROMOTION

The Promotion will be held from 9 a.m. on January 13, 2020, to 11:59:59 p.m. on February 2, 2020.

4. HOW TO ENTER

4.1 To take part in the Promotion, eligible individuals must enter promo code¹ **JEUDI4415** in their Espacejeux account during the Promotion period. Each eligible individual can only enter the promo code once (1) during the entire Promotion period.

4.2 Once duly registered in accordance with Section 4.1, eligible individuals will automatically receive **one (1) entry** for the draw described in Section 5 of these rules for each Lotto 6/49 play purchased online using real money during the Promotion period. The cost of one play is three dollars (\$3).

4.3 Eligible individuals can receive an unlimited number of entries during the Promotion period.

5. DRAW AND PRIZE DESCRIPTION

- 5.1 The Promotion's random electronic draw will be conducted on February 3, 2020, in Loto-Québec's Montréal draw room using its computer system in order to determine one (1) Promotion winner.
- 5.2 The draw among all entries duly registered during the Promotion in accordance with these rules will be conducted and supervised by authorized Loto-Québec representatives.

IN THE EVENT THAT THE ENTRY DRAWN IS DEEMED VALID AND COMPLIANT:

- 5.3 In the event that the entry drawn is valid and compliant with the rules herein, the winner will receive a prize of eight thousand dollars (\$8,000) paid by cheque, i.e. four (4) cheques of two thousand dollars (\$2,000).

IN THE EVENT THAT THE ENTRY DRAWN IS DEEMED INVALID OR NON-COMPLIANT:

- 5.4 Should the entry drawn be deemed invalid or non-compliant with the rules herein or the individual whose entry is drawn does not comply with the terms indicated in the rules herein, another entry will be drawn at random. Such draws will take place until an entry is found to be valid and compliant, in which case the terms described in Section **5.3 IN THE EVENT THAT THE ENTRY DRAWN IS DEEMED VALID AND COMPLIANT** above will apply.

6. PRIZE REMITTANCE

A Loto-Québec staff member will email or phone the winner designated in accordance with Section 5 herein to confirm the win and provide details and terms for claiming the prize. The winner must confirm their contact information and provide proof of ID within the next forty-eight (48) hours. Once the winner's identity has been checked and confirmed and compliance with these rules is ascertained, they will receive their prize by registered mail.

In the event that a winner cannot be reached within forty-eight (48) hours following the draw, is unable to meet the terms stated in the rules herein or fails to provide their contact information within forty-eight (48) hours of being reached, they will not be entitled to the prize. Another draw will be conducted, and so forth, until a valid and compliant entry is drawn and the winner meets all the conditions set out in these rules, in which case the terms described above will apply.

7. NAME, ADDRESS AND PHOTOGRAPH

The name, address, photograph and/or video of the winner, and any other information voluntarily provided, can be used by Loto-Québec and its subsidiaries not only for the draws described in the rules herein, but also for advertising purposes, particularly on the Internet (including social media as well as on promotional and Winners' pages on lotoquebec.com). The winner must waive all rights to compensation related to broadcasting, printed material and advertising.

8. OTHER RESTRICTIONS

- 8.1** Loto-Québec reserves the right to replace a prize, in whole or in part, with another of equal value.
- 8.2** Loto-Québec reserves the right to cancel or delay the Promotion, in whole or in part, for any reason whatsoever or due to an act of God or force majeure. Loto-Québec can also amend these rules at any time, in which case the amended rules will be made available to the public.
- 8.3** Loto-Québec declines all liability towards anyone should the Promotion be cancelled, delayed or modified, or in the event of a computer system failure or malfunction.
- 8.4** Loto-Québec declines all responsibility towards anyone who did not receive one or more electronic entries or a chance to enter the Promotion.
- 8.5** Loto-Québec declines all responsibility in the event of any incident or other occurrence that prevents anyone from complying with the conditions herein or deadlines for taking possession of the prize.
- 8.6** Winners who are registered in a lotoquebec.com, Québec gaming hall or casino self-exclusion program at the time a prize is claimed will not be entitled to receive said prize.
- 8.7** In the event that an individual violates these rules, makes a false statement, attempts to cheat, commits fraud, acts in collusion or conspires with a third party, their entry will be automatically cancelled and they will be ineligible for any other event related to the Promotion.

9. DISPUTES

Eligible individuals agree to comply with these rules as well as all other applicable rules and conditions indicated on lotoquebec.com. Any dispute relating to this Promotion, whether regarding conduct and/or award of any prizes, will be settled according to these rules and the Sales promotion games By-law (CQLR, c. S – 13.1, r. 4).
