

# Stroke of Fortune PROMOTION RULES

#### 1. **DEFINITIONS**

**1.1.** *Stroke of Fortune* (hereinafter the Promotion):

Promotion held pursuant to the Sales promotion games By-law (CQLR, c. S-13.1, r. 4).

# 1.2. Loto-Québec:

The Société des loteries du Québec, the party responsible for organizing the Promotion.

## 2. ELIGIBILITY

Only individuals who are eighteen (18) or older can enter the Promotion, provided they have an account on the Loto-Québec gaming website, lotoquebec.com, and their identity has been confirmed according to the applicable terms and conditions. In addition, they must not have self-excluded from a casino, gaming hall or lotoquebec.com and must not be barred from casinos, gaming halls or lotoquebec.com.

#### 3. DURATION OF THE PROMOTION

The Promotion will run from 3 a.m. on January 20, 2025, until 2:59:59 a.m. on February 17, 2025.

#### 4. HOW TO ENTER

- **4.1.** To enter the Promotion, qualified entrants must enter promo code INSTANTS10018<sup>1</sup> in their lotoquebec.com account while the Promotion is in effect. Only one (1) entry is permitted per qualified entrant for the duration of the Promotion.
- **4.2.** Once qualified entrants have entered the Promotion, in accordance with section 4.1 hereof, they will automatically receive **one** (1) **entry** for the draw described in section 5 below for every one dollar (\$1) in real money they bet on the games available under the progressive jackpots filter while the Promotion is in effect. There is no limit to the number of entries qualified entrants can earn while the Promotion is in effect.

# 5. DRAW AND PRIZE DESCRIPTION

**5.1.** The Promotion draw will be conducted electronically on February 18, 2025, from all the entries duly received, in accordance with these rules, using the Loto-Québec computer system at the Loto-Québec head office in Montréal. Ten (10) Promotion winners will be drawn.

**5.2.** The draw will be conducted and supervised by authorized Loto-Québec representatives.

#### SHOULD THE SELECTED ENTRIES BE VALID AND COMPLY WITH THESE RULES:

**5.3.** Should the selected entries be valid and comply with these rules, each winner will receive one prize of one thousand dollars (\$1,000). The cash prize will automatically be deposited into the winner's lotoquebec.com account approximately seventy-two (72) hours after the draw.

# SHOULD A SELECTED ENTRY NOT BE VALID OR NOT COMPLY WITH THESE RULES:

**5.4.** An entry will be voided if it is not valid or does not comply with these rules or if the qualified entrant whose entry is drawn fails to comply with the terms and conditions hereof. If applicable, a new entry will be drawn at random until a valid entry that complies with these rules is drawn, in which case the terms and conditions in section 5.3 will apply.

#### 6. PRIZE FULFILLMENT

The winners, designated in accordance with Section 5 of these rules, will be contacted by email or phone by a Loto-Québec staff member, who will inform them that they have won a prize and that it will be deposited into their account on lotoquebec.com.

Loto-Québec reserves the right to require winners to show or send in, among other things, a valid form of government-issued photo ID when they claim their prize. Once the winners' identities have been checked and confirmed, and their compliance with these rules has been attested, they will receive their prize, as described in Section 5 of these rules and in accordance with the terms and conditions set out by Loto-Québec.

## 7. NAME, ADDRESS AND PHOTOGRAPH

All winners consent to Loto-Québec and its subsidiaries publishing their name, region and photograph if Loto-Québec deems it appropriate. In addition, entrants hereby acknowledge and accept that their name, pseudonym, region, photograph, any video in which they appear (compliant with Loto-Québec standards) and any other information they provide may be used by Loto-Québec and its subsidiaries for the draw provided herein and advertising or marketing purposes, in particular on the Internet (including on social media and the promotional and winners pages of lotoquebec.com). Winners may claim no rights to broadcasting, printed material or advertising in this regard.

# 8. OTHER RESTRICTIONS

- **8.1.** Prizes are limited to one (1) per qualified entrant for the duration of the Promotion.
- **8.2.** The prize must be accepted as is. It may be used to play any game on lotoquebec.com. It can be redeemed for cash but cannot be exchanged or transferred.
- **8.3.** Loto-Québec reserves the right to substitute the prize for another one of equivalent value.
- **8.4.** Loto-Québec reserves the right to cancel the Promotion, in whole or in part, or postpone it for any reason whatsoever, including cases of fortuitous events or force majeure.

Loto-Québec may also amend these rules at any time, in which case the amended rules will be made available to the public.

- **8.5.** Loto-Québec declines all liability toward anyone should the Promotion be cancelled, postponed or amended, or should the computer system fail or malfunction.
- **8.6.** Loto-Québec declines all liability toward anyone who did not receive one or more electronic entries or a chance to enter the Promotion.
- **8.7.** Loto-Québec declines all liability should any situation, incident or other occurrence prevent anyone from meeting entry deadlines or claiming their prize, if applicable.
- **8.8.** No individual may be declared a winner nor claim their prize if, at the time of the draw, 1) they are self-excluded from a casino, gaming hall or lotoquebec.com, 2) they are barred from casinos, gaming halls or lotoquebec.com, or 3) they do not have an active lotoquebec.com account.
- **8.9.** Should an entrant fail to comply with these rules, make a false statement, attempt to cheat, commit fraud, act in collusion with a third party or conspire with such third party, their entry will automatically be voided, and they will be disqualified from further participation in any event related to the Promotion.

#### 9. **DISPUTES**

Qualified entrants agree to abide by the rules herein and all other rules and conditions that apply to lotoquebec.com. Any disputes in connection with the Promotion and prize fulfillment process will be governed by these rules and the *Sales promotion games By-law* (CQLR, c S-13.1, r. 4).
