

PROMOTION RULES

Destination Promotion

1. DEFINITIONS

1.1. *Destination Promotion* (hereinafter the “Promotion”):

Promotion held pursuant to the *Sales promotion games By-law* (CQLR, c. S-13.1, r. 4).

1.2. Loto-Québec:

The Société des loteries du Québec, the party responsible for organizing the Promotion.

2. ELIGIBILITY

Only individuals who are eighteen (18) years of age or older can enter the Promotion, provided that they have an account on lotoquebec.com, that their identity has been confirmed according to the applicable terms and conditions and that they are residents of Québec. Moreover, they must not be enrolled in a self-exclusion program that bars them from Loto-Québec's online gaming website and/or Québec casinos and gaming halls, and they must not have been denied access to Loto-Québec's online gaming website or Québec casinos and gaming halls.

3. DURATION OF THE PROMOTION

The Promotion will run from January 16, 2023, at 3 a.m., until February 6, 2023, at 2:59:59 a.m.

4. HOW TO ENTER

4.1. To enter the Promotion, eligible individuals must first enter promo code¹ INSTANTS7109 in their account on lotoquebec.com during the Promotion period. Only one (1) entry is permitted per eligible individual for the duration of the Promotion.

4.2. Once eligible individuals have entered the Promotion, in accordance with Section 4.1 of these rules, they will automatically get **one (1) entry for the draw**, as described in Section 5 of these rules, for every dollar in real money they bet during the Promotion period on the following online games, which are available on lotoquebec.com: Tiki-Tac-Toe, Tic-Tac Temple, Volcano, Jungle Tumble, Gem Stacks, Mad Mad Monkey, Gorilla Go Wild, Gorilla Go Wilder, Feathered Frenzy Tapcard, Summer Landmarks, Gone Fishin', Fruit Punch Up, Pharaon réaction, Expérience VR, Dublin' Doubloons, À la piscine, Siren's Kingdom Scratch,

Sunken Treasure, Juicy Loot, Foxin' Wins Again Reveal, Lucky Falls and Lucky Larry's Lobstermania Tic-Tac-Toe.

- 4.3.** There is no limit to the number of entries each eligible entrant can earn during the Promotion period.

5. DRAW AND PRIZE DESCRIPTION

- 5.1.** The Promotion draw will take place on February 8, 2023, in the form of an electronic draw conducted using Loto-Québec's computer system, at Loto-Québec's head office in Montréal, to select two (2) Promotion winners.
- 5.2.** A draw from among all the entries received will be conducted, in accordance with the terms and conditions of these rules, and supervised by authorized Loto-Québec representatives.

IN THE EVENT THAT THE SELECTED ENTRIES ARE VALID AND COMPLY WITH THESE RULES:

- 5.3.** Provided that the selected entries are valid and comply with these rules, the winners will each receive a prize of five thousand dollars (\$5,000), which will be deposited directly in their account on lotoquebec.com², as per the terms and conditions in Section 6.

IN THE EVENT THAT A SELECTED ENTRY IS NOT VALID AND DOES NOT COMPLY WITH THESE RULES:

- 5.4.** An entry will be void if it is not valid or does not comply with these rules, or if the entrant fails to comply with the terms and conditions of these rules. A new entry will then be drawn at random until a valid entry that complies with these rules is drawn, in which case the aforementioned terms and conditions in Section 5.3 will apply.

6. PRIZE REMITTANCE

The winners, designated in accordance with Section 5 of these rules, will be contacted by email or phone by a member of Loto-Québec's staff, who will inform them that they have won a prize and that it will be deposited in their account on lotoquebec.com.

Upon confirming their win, Loto-Québec may require the winners to show a valid government-issued piece of photo ID. Once the winners' identity has been checked and confirmed, and their compliance with these rules has been attested, they will receive their prize, as described in Section 5 of these rules and in accordance with the terms and conditions set out by Loto-Québec.

7. NAME, ADDRESS AND PHOTOGRAPH

All winners authorize Loto-Québec and its subsidiaries, when the SCQ deems it necessary, to publish their name, region and photograph. In addition, entrants hereby acknowledge and accept

that their name, pseudonym, region, photograph, video in which they appear (compliant with Loto-Québec standards) and any other information they provide may be used by Loto-Québec and its subsidiaries for the purposes of both the draws provided herein and advertising or promotional initiatives, in particular on the Internet (including on social media and lotoquebec.com's promotional and winners pages). No rights to broadcasting, printed material or advertising can be claimed in this regard.

8. OTHER RESTRICTIONS

- 8.1.** Limit of one (1) prize per eligible entrant for the duration of the Promotion.
- 8.2.** The prize must be accepted as is. It may be redeemed for cash but cannot be transferred or exchanged.
- 8.3.** Loto-Québec reserves the right to substitute the prize for another one of equivalent value.
- 8.4.** Loto-Québec reserves the right to cancel the Promotion, in whole or in part, or postpone it for any reason whatsoever, or in cases of fortuitous events or *force majeure*. Loto-Québec may also amend these rules at any time, in which case the amended rules will be made available to the public.
- 8.5.** Loto-Québec declines all liability towards anyone should the Promotion be cancelled, postponed or amended, or in the event of a computer system failure or malfunction.
- 8.6.** Loto-Québec declines all liability towards anyone who may not have received their electronic entry (or entries) or earned the right to enter the Promotion.
- 8.7.** Loto-Québec declines all liability in the event of any situation, incident or other occurrence that prevents anyone from meeting entry deadlines or claiming their prize.
- 8.8.** A person may not be declared a winner, nor will they be entitled to their prize if, at the time of the draw, i) they are enrolled in a self-exclusion program that bars them from Loto-Québec's online gaming website and/or Québec casinos and gaming halls, or ii) they have been denied access to Québec casinos and gaming halls.
- 8.9.** If an entrant fails to comply with these rules, makes a false statement, attempts to cheat, commits fraud, acts in collusion or conspires with a third party, their entry will automatically be void and they will be disqualified from further participation in any event related to the Promotion.

9. DISPUTES

Eligible individuals agree to abide by these rules and all other applicable rules and conditions stated on lotoquebec.com. Any dispute related to the management of the Promotion and awarding of prizes will be settled according to these rules and the *Sales promotion games By-law* (CQLR, c. S-13.1, r. 4).
