

## PROMOTION RULES

### *Lottery Subscription*

---

#### 1. DEFINITIONS

**1.1. *Lottery Subscription*** Promotion (hereinafter the “Promotion”):

Promotion held as per the *Sales promotion games By-law* (CQLR, c. S-13.1, r. 4).

**1.2. Loto-Québec:**

The Présidence des opérations – Loteries for the Société des loteries du Québec, responsible for organizing the Promotion.

#### 2. ELIGIBILITY

Only individuals who are eighteen (18) years of age or older can enter the Promotion, provided that they have an Espacejeux account on lotoquebec.com, that their identity has been confirmed according to the applicable terms and conditions, that they are residents of Québec, and that they are not enrolled in a self-exclusion program that bars them from Loto-Québec’s gaming website and/or Québec casinos and gaming halls.

#### 3. DURATION OF THE PROMOTION

The Promotion will run from August 2, 2021, at 8 a.m., until August 22, 2021, at 11:59:59 p.m.

#### 4. HOW TO ENTER

**4.1.** To enter the Promotion, eligible individuals must first enter promo code ABL0T5592 in their Espacejeux account during the Promotion period. Only one (1) entry is permitted per eligible individual for the duration of the Promotion.

To enter the promo code, eligible individuals must click on My Account in the upper right-hand corner of the screen, then click on My Promotions in the left-hand menu.

**4.2.** Once eligible individuals have entered the Promotion, in accordance with Section 4.1 of these rules, they will automatically receive one (1) entry for the draw, as described in Section 5 of these rules, insofar as they have an active lottery subscription on lotoquebec.com at the time of the draw.

## **5. DRAW AND PRIZE DESCRIPTION**

**5.1.** The Promotion draw will take place on August 24, 2021, as an electronic draw from all the entries duly received, in accordance with these rules. The draw will be conducted using Loto-Québec's computer system, at the Corporation's head office, in Montréal, in order to select five (5) Promotion winners.

**5.2.** The draw will be conducted and supervised by authorized Loto-Québec representatives.

### **IN THE EVENT THAT THE SELECTED ENTRIES ARE VALID AND COMPLY WITH THESE RULES:**

**5.3.** In the event that the entries drawn are valid and comply with these rules, the five (5) winners will each receive one (1) prize of one thousand dollars (\$1,000), which will automatically be deposited in their Espacejeux account.<sup>1</sup>

### **IN THE EVENT THAT A SELECTED ENTRY IS NOT VALID OR DOES NOT COMPLY WITH THESE RULES:**

**5.4.** In the event that a selected entry is not valid and does not comply with these rules, a new entry will be drawn at random until a valid entry that complies with these rules is drawn, in which case the aforementioned terms and conditions in Section 5.3 will apply.

## **6. PRIZE REMITTANCE**

The winners, designated in accordance with Section 5 of the rules herein, will be contacted by email or phone by a member of Loto-Québec's staff, who will then confirm that they have won a prize and that it has been deposited in their Espacejeux account.

Loto-Québec can require the winners to show a valid form of government-issued photo ID before remitting the prize. Once the winners' identity has been checked and confirmed, and their compliance with these rules has been attested, they will receive their prize, as described in Section 5 of these rules and in accordance with the terms and conditions set out by Loto-Québec.

## **7. NAME, ADDRESS, PHOTOGRAPH AND VIDEO**

The winners' name, address, photograph or video, and any other information voluntarily provided by them, may be used by Loto-Québec and its subsidiaries not only for the purposes of the draw described in these rules, but also for advertising purposes, particularly on the Internet (including on social media). The winners may claim no rights to broadcasting, printed material, or advertising in this regard.

## **8. OTHER RESTRICTIONS**

**8.1.** The prize must be accepted as is but cannot be exchanged or transferred.

<sup>1</sup> The cash prize will automatically be deposited in the winners' Espacejeux account approximately seventy-two (72) hours after the draw. The money they win can be used to play any of Loto-Québec's online games. The prize can be redeemed for cash, but cannot be exchanged or transferred.

- 8.2. Loto-Québec reserves the right to replace a prize with another of equal value.
- 8.3. No compensation will be paid in the event that a winner is unable to claim their prize.
- 8.4. Loto-Québec reserves the right to cancel or delay the Promotion, in whole or in part, for any reason whatsoever or due to an act of God or force majeure.
- 8.5. Loto-Québec declines all liability towards anyone should the Promotion be cancelled, postponed or amended, or in the event of a computer system failure or malfunction.
- 8.6. If an entrant fails to comply with these rules, makes a false statement, attempts to cheat, commits fraud, acts in collusion or conspires with a third party, their entry will automatically be void and they will be disqualified from further participation in any event related to the Promotion.
- 8.7. Loto-Québec may amend these rules at any time, in which case the amended rules will be made available to the public.
- 8.8. Loto-Québec declines all liability towards anyone who may not have received their electronic entry (or entries) or earned the right to enter the Promotion.
- 8.9. Loto-Québec cannot be held responsible for any situation, incident or any other event that prevents any individual from respecting participation deadlines or confirming the acceptance of the prize by the deadline.
- 8.10. Any winner who is enrolled in a self-exclusion program that bars them from lotoquebec.com and/or Québec casinos and gaming halls at the time of the draw will not be entitled to the prize they won.

## 9. DISPUTES

Eligible individuals agree to abide by the rules herein and all other applicable rules and conditions stated on lotoquebec.com. Any dispute related to the management of the Promotion and awarding of prizes will be settled according to these rules and the *Sales promotion games By-law* (CQLR, c. S-13.1, r.4).
